

Terms and conditions

1. General

The opening time and date of the prize draw is **19/12/2017 at 09:00 GMT**, and the closing date and time for receipt of entries is the **01/01/2018 at 16:00 GMT**, (the "Contest Period") Entries submitted after this time will not be considered.

2. Restrictions

1. This prize draw is open to UK residents aged thirteen (**13**) and over only. Entrants under the age of thirteen (**13**) require parental consent to enter the prize draw.
