

The promoter of the draw is Wolverhampton Wanderers Football Club Limited (the "Club", "us", "we") of Molineux Stadium, Waterloo Road, Wolverhampton, WV1 4QR.

These draw terms and conditions (the "Terms") are in addition to the Club's Terms of Use and the Club's Privacy Statement and apply to the draw operated by the Club through wolves.co.uk for a chance to purchase a pair of tickets for the 2019 FA Cup Semi Final at Wembley Stadium, London on 7 April 2019 at 4pm between Wolverhampton Wanderers and Watford Football Club (the "Draw").

The Draw is now open and shall remain open until 5pm (UK time) on Sunday, 31 March 2019 (the "Closing Date"). In order to enter the Draw please visit the Club's website at www.wolves.co.uk and enter your details on the ballot form.

The Draw is subject to strict entry requirements and you should therefore carefully read the Terms below.

1 Draw Entry Requirements

1.1 The Draw is free to enter and no purchase is necessary.

1.2 To enter the Draw, you should meet the following requirements:

(a) You are not subject to a banning order from any football games or stadia in the United Kingdom or abroad;

(b) You are not an employee, director, agent (or a family member of any of them) of the Club or of one of the Club's group companies;

(c) You are at least 12 years old (although if you are under 18, win and purchase tickets for the Match, you will need to be accompanied by an adult);

1.2 By entering the Draw you warrant that all information you submit is true and that you have the authority and capacity (or, if relevant, have appropriate permission from a parent or guardian) to enter. We reserve the right to require written proof of your age to confirm that you are eligible to enter the Draw.

1.3 The Club reserves the right to reject any entries:

(a) not received by the Closing Date or any entry which is incomplete or incorrect;
or

(b) where we have reasonable grounds to believe the entrant is in breach of any of these Terms.

1.4 Only one entry per person is permitted.

2 Winners' Selection

2.1 The Draw winners will be determined by means of a random selection of valid entries to be conducted by the Club within one (1) day of the Closing Date, in the presence of an independent observer.

Each of the winners will be sent a notification from the Club by email on Monday 1st April 2019.

2.2 Once notified, the Club will provide you with the opportunity to purchase a pair of tickets for the 2019 FA Cup Semi-Final at Wembley Stadium, London on 7 April 2019 at 4pm between Wolverhampton Wanderers and Watford Football Club (the "Match").

If you decide to purchase the tickets, you will be required to have purchased these tickets by 5pm (GMT) on Tuesday 2nd April 2019.

2.3 The Club reserves the right to disqualify your selection as a winner and to select an alternative winner at random, in circumstances where:

(a) you have failed to complete or decided not to complete your tickets purchase within the period stated at 2.2 above;

(b) you have already purchased a ticket for the Match by qualifying and purchasing via the existing priority ticketing criteria.

3 Purchase Match tickets

3.1 Being selected as one of the winners of the Draw gives you the right to purchase from the Club at face value two level 5 tickets for the Match (the "Prize").

3.2 Please note that prices for the tickets may vary dependent on exact location. The Club does not provide any substitution or alternative for the Prize, including any cash alternative and you will not be able to transfer the Prize to another person.

3.3 You should note that as winner of the Prize, you will be required to comply with any terms and conditions applicable to the Prize and to any rules that may be applicable or in force at Wembley Stadium, including without limitation, the ground regulations.

3.4 Under no circumstances will you re-sell or supply such tickets to any third party.

3.5 Winners will need to make their own travel and (where required) accommodation arrangements to the Match.

The Prize does not include any costs, expenses, fees or taxes associated with the winners' travel or accommodation expenses in connection with the Prize and the Club will have no liability in this respect.

3.6 The Club reserves the right in its absolute discretion to cancel the Draw and/or the Prize where circumstances outside of the Club's control arise (including any acts or omissions from any third parties) which would prevent the Club from being able to deliver the Prize. Any changes to the Draw and/or the Prize will be notified to entrants as soon as possible by the Club.

4 Promotion

If you are selected as a Prize winner, you agree to take part in reasonable publicity and promotion (where so requested by the Club) that may be organised by the Club.

Winners also agree to the Club's reasonable use of their name and/or image in connection with such promotion.

5 Liability

5.1 Subject to clause 5.3 below, the Club accept no responsibility or liability and shall not be responsible or liable for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Draw or winning or purchasing the Prize.

5.2 We are not responsible for any problems or technical issues with any telephone lines, computer systems, websites, servers or service providers, nor for any error, omission, interruption, defect, delay in transmission, theft, destruction or unauthorised access to entries, nor for the consequences of any computer virus, bug or any other faults that may affect the Draw or any entries to the Draw or any purchase of the Prize.
