CONDITIONS OF ISSUE



This ticket is issued by the Club subject to the Terms & Conditions of Entry (which are available from the Club). The use of this ticket to enter the Club's stadium ("Stadium") constitutes acceptance of the Club's Terms & Conditions of Entry. Your attention is drawn to the following summary of certain provisions from the Terms & Conditions of Entry:

Other than as set out in the Terms & Conditions of Entry, you may not transfer this ticket to anybody. The unauthorised sale or disposal of tickets is a criminal offence under section 166 of the Criminal Justice and Public Order Act 1994, as amended by the Violent Crime Reduction Act 2006.

You may not use this ticket in any way for any commercial purpose save as expressly authorised by the Premier League, EFL or the Club.

This ticket shall remain at all times the property of the Club.

If this Ticket is obtained or used in breach of the Terms & Conditions of Entry, it will be automatically void. The bearer will be refused entry and, if already in the Stadium, will be ejected, in either case without refund.

Except mobile phones used for personal and private use only, you may not bring into (or use within) the Stadium any equipment that is capable of recording or transmitting any audio, visual or audio-visual material or any information or data in relation to a match or any aspect of it.

The Club reserves the right to eject from the Stadium, any person who fails to comply with the Terms & Conditions of Entry.

Match ticket refunds are only granted if the ticket is returned to the ticket office a minimum of 48 hours before kick-off in line with the Club's Customer Charter. Travel ticket refunds are only permitted if the ticket is returned to the office 48 hours before departure. If the game is postponed for any reason the ticket will remain valid for the re-arranged date. Alternatively, the price paid for the ticket can be refunded provided that it is received at the ticket office not less than 48 hours prior to the re-arranged kick-off time. If a game is abandoned after spectators have been admitted into the stadium then the policy for the re-arranged date will be as per the Club's Customer Charter and will be governed by the time played before abandonment.
